The indemnification contained herein extends to the payment of attorney fees and costs, if any, incurred by the City of Paris, its agents, servants, successors in any suit arising from such volunteer or community service work. This release and indemnification further extends to any actions or inactions on my part which cause injury to persons or property, including myself, including the operation of motor propelled vehicles.

By my signature below, I hereby further certify that both the minor child and myself have read and understand the guidelines and requirements for Vendors, that we agree to abide by same, and that any violation thereof will result in revocation of the privileges associated with the being a vendor or participating in the Youth Entrepreneur program, may result in immediate removal from the Farmer's Market property, and may result in the minor child's not being allowed to participate in the program in the future.

It is understood and agreed that this Property Damage and Personal Injury Release is not to be construed as an admission of liability on the part of the party or parties hereby released, (The City of Paris), and that said release denies liability therefore of the City of Paris, its employees, agents, or assigns, should I or the minor child damage any citizen's personal property or cause injury to any person and places all liability with myself.
